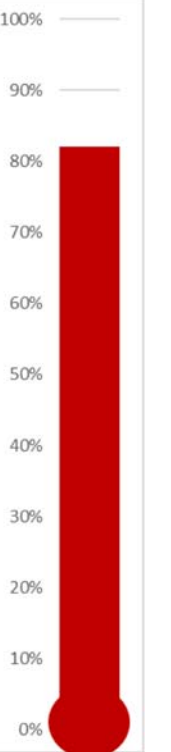
support, **over \$2.8M has been pledged or donated toward the campaign!** This represents 82% of our adjusted campaign goal.

Our total goal is \$3.45M. Why the increase? Construction costs were higher than initially estimated (estimates were made extremely early in the process) but the majority of the increase was due to the following factors/improvements:

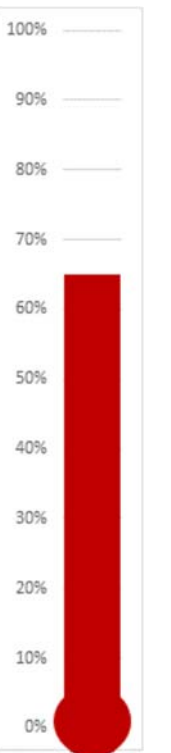
- In order to maximize the visual space in the addition to the church vestibule, a barrel ceiling was added. Other additional church costs included internal gutters and tying in the new and old roof lines in a more aesthetically pleasing way.
- Although we did plan and budget to lease temporary portable classrooms, we had the opportunity to instead purchase 2 buildings from another school that we can keep permanently on our campus. So while our original estimates gave us a total of 6 new classrooms, we will now have a total of 10 new classrooms after construction is complete. This is much needed as several high school teachers currently have to share classrooms.
- Keeping these portable buildings mean we also have more classrooms than expected that will need to be furnished.
- This project also gave us the opportunity to take care of some electrical work on campus that was long overdue. The pole that was precariously standing between the high school and elementary buildings has been removed, as have other poles, with the result of the burial of quite a bit of electrical supply. This was costly, but a valuable addition to the beauty and safety of our campus as well as the reliability of electrical service.
- There were several upgrades made to the safe room that were above the initial estimates. This is money well spent to ensure the highest level of safety.
- Metal canopies were added to the school entrances.
- The oval in the parking lot will have to be reduced for traffic flow.
